I hereby present to you the Interim Report of the District Committee of General Purposes.

At the District Annual Convocation and Installation meeting held on the 27th March, 2018 I was appointed President of the Committee of General Purposes.

Since my appointment, the Committee has had three (3) meetings.

E. Companion Dr. Harold B. Davis was elected Vice President at the first meeting.

Obituary

Since the Installation meeting 27th March, 2018, regrettably, the following Brother has ascended to the Grand Lodge above:

Financial Matters

At the 15th of September, 2018, seven (7) Chapters were indebted to District Grand Chapter in the accumulated sum of \$813,000. The period of indebtedness is from the year 2015 to 2018.

I wish to urge those Chapters and Companions who are indebted to District Grand Chapter for dues and ticket monies to settle their indebtedness to Grand Chapter. I ask you to be mindful that the proceeds of all ticket sales go to some worthy charitable or benevolent activity. Therefore, your failure to settle your indebtedness adversely affects our benevolent efforts and deprives a person in need.

Annual Returns

As at the 15th September, 2018, five (5) Chapters had not submitted their Annual Returns for the year ended December, 2016. These Chapters ought to put themselves in order.

Installation Returns

At as at 15th September, 2018:

- one (1) Chapter had not submitted Installation Returns for 2014.
- Five (5) Chapters had not submitted Installation Returns for 2015
- One (1) Chapter had not submitted Installation Returns for 2016.
- Two (2) Chapters had not submitted Installation Returns for 2017.
- Ten (10) Chapters had not submitted Installation Returns for 2018.

Other Administrative Matters

The District Grand Chapter embarked on a drive to exalted eligible masons to Royal Arch. To this end, by the end of September, 2018 over fifteen (15) masons were exalted in various Chapters.

In keeping with one of the District Grand Chapter's program to revive and resuscitate the Chapters which have fallen off and have not met for an extended period of time, efforts were made in this regard. A team of E. Companions was formed to assist in the exaltation of eligible masons. This team worked largely out of the resuscitated Eureka Chapter No. 8515 and Silent Temple Chapter No.3254 and has exalted twelve (12) Companions.

An awareness meeting intended to sensitize masons about the Royal Arch was hosted at Eureka Chapter No. 8515. W. Bro. Phil Young did the address. It evolved into a very interactive and informative session, which also involved young masons, about the Royal Arch and why masons should join.

The Committee and indeed the District Grand Chapter are entirely grateful to those who have played a part in making the exaltation and revival efforts successful.\

Guidance Notes/Secretariat Outreach

The Committee has established a format for some documents held by the Chapters and submitted to District Grand Chapter and the M. E Grand Superintendent These are:

- i) Minutes
- ii) Report of the Most Excellent Z
- iii) Most Excellent Z's Plan
- iv) Visiting Officers form.

Guidance notes in this regard have been circulated to the Chapters. These notes are not intended to change one's style of writing but are intended to point out what items must be included. It assists with better record keeping and provides important information for the District Grand Chapter administration.

The Board mandated the District Grand Scribe and the Treasurer to meet with Chapter Scribes E and Treasurers to deal with such matters as Annual and Installation returns, explanation of the new guidance notes. It was also an interactive session to understand and address, where possible, the challenges faced by the chapter scribes and treasurers in the execution of their duties and improve the relationship and communication between the District Grand Scribe and the Chapters.

On the 8th day of September, 2018 the District Grand Chapter hosted a forum for Lodge Scribes.

This forum involved a presentation by Professor Susan Snell BA DAA MA RMARA, Archivist and Records Manager of the Library and Museum, United Grand Lodge of England, on record keeping and record preservation.

Scribes under the Scottish Constitution, pursuant to an invitation by District Grand Chapter, attended and participated at this forum.

I wish to thank the members of the Committee and all those Companion who assisted for their hard work thus far and say that we have miles to go and that collectively we can further develop the programs for free masonry in Guyana.

INDEPENDENT AUDITOR'S REPORT TO THE SHAREHOLDERS OF DISTRICT GRAND CHAPTER OF GUYANA.

Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of District Grand Chapter of Guyana which comprise the Statement of Financial Position as at 31 December 2017, the Statement of Profit or Loss and the Statement of Changes in Equity and the Statement of Cash Flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies as set out in pages 6 to 7.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the friendly society as at December 31, 2017, and of its financial performance and its cash flows for the year then ended in accordance with International Financial Reporting Standards.

Basis for Opinion

We conducted our audit in accordance with International Standards on Auditing. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the friendly society in accordance with the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants together with the ethical requirements that are relevant to our audit of the financial statements, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the International Ethics Standards Board for Accountants' Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with International Financial Reporting Standards, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error. In preparing the financial statements, management is responsible for assessing the company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the company or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the company's financial reporting process.

 misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve
 collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures
 that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the
 effectiveness of the company's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the company's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the company to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the
 disclosures, and whether the financial statements represent the underlying transactions and events in a
 manner that achieves fair presentation.
- Obtain sufficient appropriate audit evidence regarding the financial information of the entities or business activities within the company to express an opinion on the financial statements. We are responsible for the direction, supervision and performance of the company audit. We remain solely responsible for our audit opinion.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.
