#### Address by the District Grand Master

The District Grand Master addressed the brethren. He focussed on the need for masons to apply in their communities and in their relations to each other the tenets learned from our masonic rituals. He stated that:

- $\sqrt{}$  according to the author, Bother Robert Davis, the whole purpose of masonic ritual is to provide a map which indicates how masons and others should act;
- the Worshipful Master at his installation is exhorted, among other things, to charge the brethren to practise out of the lodge those duties that they have been taught in it;
- ✓ our Grand Principles of Brotherly Love, Relief and Truth serve as the North Star in our changing world and equip us with the philosophy and values essential for us to comfort and alleviate problems in our communities;
- $\checkmark$  masonic tradition and history augment our rituals by illustrating how masons should act;
- the ritual requires us to live not apart from our community, not aloof of our neighbours, but to love our neighbour, our neighbour being everyone in every parish or country irrespective of that person's race, gender, disability, social status, religion or political persuasion;
- $\sqrt{}$  by providing more than just money, freemasonry can significantly contribute to the alleviation of the many social problems of the region;
- according to the author, David West, the word charity has today come to mean little more than the giving money. The target of relief is specific, not impersonal. Relief is of the person, an individual and while it may be about money it is more about behaviour. The giving of money must be accompanied by a motivation of mercy, compassion or

pity;

- $\sqrt{}$  in contemplating our response to the problems plaguing our communities we must be very mindful of that response and of our behaviour;
- ✓ we should bear in mind the view of the Assistant Grand Master, the R. W. Bro. Sir David Wootton that "we want our halls and centres to be at the centre of our local community. Maybe we should refer to them as Masonic Community Centers";
- ✓ we should also be mindful of the views of the Most Worshipful Grand Master, His Royal Highness, the Duke of Kent, who had urged that charity is not just about raising money and making contributions to good causes, valuable though these are, it has a broader and deeper purpose. Apart from giving alms and providing help to those in need or in distress, charity is defined as love of one's fellow man, as kindness, and as a leniency in judging others. The Most Worship Grand Master had further urged that as masons, we should try to involve ourselves to a greater extent in activities which bring joy and happiness into the lives of disadvantaged people, and not just assume that a cash donation discharges our obligations;
- ✓ in the context of the foregoing, it is not just the responsibility of the District and individual lodges, but of every mason to inculcate a greater awareness of our role and capacity to contribute positively in our communities. Every mason by embracing his community would be able to transmit the essence of masonry into our lives and the community. We would need to volunteer more of our time, expand the type and range of our community activity, collaboration with civic and social organisations on community issues if necessary to deliver relief in our communities;
- by demonstrating our commitment to our communities we preserve our heritage, discharge our responsibilities to the needy and distressed, whilst fulfilling the true fraternal responsibility we owe to our fellow creatures.

#### Remarks by Bro. Phillip Smith, Past Substitute DGM, Scottish Constitution

Bro. Smith addressed the brethren. He apologise for the unavoidable absence of the R. Wor. District Grand Master, Bro. Brig. (ret'd) Edward O. Collings, MSM, congratulated R. Wor. Bro. R. Forde for his leadership and commended the work being done by the District Grand Lodge.

I hereby present to you the Interim Report of the District Board of General Purposes.

At the Annual Communication of District Grand Lodge and the Installation of the R. W. District Grand Master held on the 27th March, 2018 I was appointed to the office of President of the District Board of General Purposes. Since my appointment, the Board has held three (3) meetings at the first of which W. Bro. Errol Hanoman was elected to the office of Vice President of the Board.

#### **Financial Matters**

At 15th September, 2018, the Account Balances of District Grand Lodge were as follows:

At the 15th of September, 2018, seven (7) lodges were indebted to District Grand Lodge for dues in the accumulated sum of \$1,228,000. The period of indebtedness is from the year 2014 to 2018.

#### **Annual Returns**

As at the 15th September 2018, five (5) lodges had not submitted their Annual Returns for the year ended December, 2016. I must note that of the five lodges, three (3) have not met for some time. The two other lodges ought to put themselves in order.

#### Installation Returns

As at 15th September 2018:

- one (1) lodge had not submitted Installation Returns for 2014.
- Five (5) lodges had not submitted Installation Returns for 2015
- One (1) lodge had not submitted Installation Returns for 2016.
- Two (2) lodges had not submitted Installation Returns for 2017.
- Ten (10) lodges had not submitted Installation Returns for 2018.

#### **Other Matters**

The Board has received the District Grand Lodge budget for the year 2018/2019 and the reports of the District Grand Treasurer, the District Board of Benevolence and the District Grand Mentor's Plan. These Reports will be presented at the meeting.

I wish to urge those lodges and brethren who are indebted to District Grand Lodge for dues and ticket monies to settle their indebtedness immediately. I ask you to be mindful that the proceeds

of all ticket sales go to some worthy charitable or benevolent activity. Therefore, your failure to settle your indebtedness adversely affects our benevolent efforts and deprives a person in need.

#### New and Young Members Club

On the 14th April, 2018 the New and Young Members Club was launched. I later presided at the first meeting of this club for the purpose of election of its office bearers.

Bro. Randy Prashad was elected President of the Club.

## Forum of Installed Masters

The forum was launched for a second time and W. Bro George Jervis was elected President.

#### **Revival of the Lodges**

In keeping with one of the District Grand Lodge's programs to revive and resuscitate the lodges which have fallen off and have not met for an extended period of time, several lodges were revived. To this end, Kara-Kara Lodge No. 8349 saw the election and Installation of a new master and the reception of a number of joining members. W. Bro Atukunde Cameron was elected and installed as master at a meeting held in Georgetown in April, 2018. This lodge has since successfully planned at least one fundraiser.

The Guyana Lodge of Research No.8525 was also revived. On 6th June, 2018 W. Bro. Lee Baptiste was elected and installed as master of the lodge. Seven joining members were also received by the lodge at that installation meeting.

It was resolved that the University Lodge of Guyana No.9331 will install a new Master in November of this year and a plan of the role of that lodge in conjunction with the University Scheme has been mapped out. There are several proposed joining members.

A delegation, including representatives of District Grand Lodge, met with the University of Guyana Student Executive and Student Council to foster a relationship with the University community to promote and develop the UGLE University Scheme.

Eureka Lodge No.8515 is busy again. This lodge received several joining members and has done an initiation ceremony after several years. An awareness meeting intended to sensitize masons about Holy Royal Arch masonry was hosted by this lodge at which W. Bro. Phil Young, 3rd District Grand Principal, delivered an address about the Order. The address was followed by a very interactive and informative session about the Order and why master masons should become Royal Arch masons.

At a meeting held on 12th May 2018 the members of Ituni Lodge No. 2642 and Phoenix Lodge No.9517 indicated a desire to have both lodges resuscitated and on the 21st July 2018 both lodges were resuscitated and new masters installed. W. Bro. Christopher Mathias was elected and installed as Worshipful Master of Ituni Lodge and W. Bro. Andre Joseph was elected and installed as Worshipful Master of Phoenix Lodge.

In an effort to promote and encourage freemasonry and the works of freemasonry in Berbice, two activities were undertaken:

 A Medical Outreach was held in New Amsterdam. Prostate screening, medical check-ups and dental check-ups were done to almost 100 persons.

> Television interviews were done and broadcasted on National Communications Network. This gave District Grand Lodge an opportunity to be seen out there for what masons do.

District Grand Lodge undertook the renovation of the masonic building at Ferry Street,

New Amsterdam. The building was cleaned, extensive renovation works were done to the structure and the interior and exterior of the building were repainted.

2. On the 21st July 2018 a Special Communication of District Grand Lodge was held at Freemasons' Hall, Ferry Street. The Communication was well attended by brethren of the District and a deputation from the Scottish Constitution.

It is hoped that these efforts coupled with those to come would reposition freemasonry in Berbice, send a positive image about freemasonry in the area, recharge the interest of the masons of Ituni and Phoenix lodges and arouse serious interest from just and upright men in Berbice in particular and Guyana in general.

The Board and indeed District Grand Lodge are entirely grateful to those who have played a part in making these revival efforts realized.

#### Freemasons' Hall, Company Path

Following an emergency meeting held on 2 May 2018 a leak in the roof of the masonic building and an infestation of pigeons which caused damage to the ceiling were remedied the very next day.

In September last the building was cleaned and renovation works were done.

The Board is in possession of an estimate of the cost for further repairs to the masonic building.

The future of the masonic building is still under active consideration. Be assured that the underlying objective is to have a building that can take us well into the future, meet our masonic needs and sustain itself.

A meeting was convened with representatives of Mount Olive Lodge No. 385 and of the District Grand Lodge to discuss collaboration in the program to rehabilitate Freemasons' Hall at Company Path. Those discussions are ongoing.

#### **District Grand Lodge Secretariat and Caretaker Accommodation**

The Board has resolved that a secretariat will be placed at the upper floor of the existing cottage at Company Path. In addition, a separate caretaker accommodation will be constructed south of the existing cottage.

#### **Guidance Notes/Secretariat Outreach**

The Board has established a format for some documents held by the lodges and submitted to District Grand Lodge and the R.W. District Grand Master.

These are:

- i) Minutes
- ii) Report of the Worshipful Masters
- iii) Worshipful Masters Plan
- iv) Visiting Officers form.

Guidance notes in this regard have been circulated to the lodges. These notes are not intended to change one's style of writing but to point out what items must be included in the documents. The items assist with better record keeping and provide important information for the District administration.

The Board mandated the District Grand Secretary and Treasurer to meet with Lodge Secretaries and Treasures to deal with such matters as Annual and Installation returns and explanation of the new guidance notes. It was also an interactive session to understand and address, where possible,

the challenges faced by the lodge secretaries and treasurers in the execution of their duties and improve the relationship and communication between the District Grand Secretary and the Lodges.

On the 8th day of September 2018 the District Grand Lodge hosted a forum for Lodge Secretaries. This forum involved a presentation by Ms Susan Snell, BA DAA MA RMARA, Archivist and Records Manager of the Library and Museum, United Grand Lodge of England, on record keeping and preservation of documents.

#### **District Grand Lodge Website**

The District Grand Lodge website has been reformed. It now embraces a number of features which include a calendar of events, profiles of District Officer and general information on the lodges and District Grand Lodge.

We continue to invite ideas as we strive to have an outstanding web site.

#### Membership Retention Rate Survey

A survey of the retention rate of masons has been commissioned. As the response to the survey was only 20% of the membership it is proposed to relaunch the survey to secure maximum participation of the membership.

#### **Other Matters**

The Board noted with admiration and approval the initiative of the "Travelling Gavel" launched by Union Lodge and resolved to lend its support, and encourages all lodges to support the initiative and to recognise, on a yearly basis, the lodge that was outstanding in this event.

The Board also noted the initiative of Union Lodge to launch the R. W. Bro. Richard Berkeley Fields, SC, LLM (Merit) (Lpool) Memorial Lecture Series and encourages other lodges to underttake such or similar initiatives.

I wish to thank the members of the Board and all those brethren who assisted for their hard work thus far and say that we have miles to go further, and collectively, we can further develop the programs for freemasonry in Guyana.

The Board in keeping with its mandate to effectively administer efficiently the activities for the programmes approved for 2018, held six (6) committee meetings following the first meeting of the Board of Saturday April 17, 2018. Set out below is a brief update on its activities/achievements:

It must be noted that W. Bro. William Andrew Boyle, District Grand Almoner, was invited to all of the committee meetings.

#### Curry Que and Karaoke

The Board held its first fund raiser on June 24, 2018 which was a Curry Que and Karaoke event at the OMG venue on Sheriff Street. It was anticipated that \$800,000 would have been realized from this venture but based on the Income and Expenditure statement our Surplus is \$790,349.

However, to date \$456,500 is still outstanding from Lodges and Brethren and I am prepared to provide information on the defaulters to the hierarchy of the District to assist in recouping this amount.

#### **Bursaries for Children of Masons**

- Bursaries will be awarded to the top eight (8) children of Masons
- Bursary would be fifty thousand dollars (\$50,000) per child (Includes cost of a Plaque)
- The Lodge Secretaries were given notice of the Award and applications forms were made available to Masons.

#### Fund Raising Cricket Match and Guyanese Lunch

- The Target for this Fund Raiser is \$3,000,000.
- Members of the Committee met with the President of Georgetown Cricket Club and discussed the use of the GCC facilities and a formal request was subsequently sent.
- The design for the Tickets was approved by the Committee and printed and 1,000 tickets distributed at a cost of \$2,000 each.
- Letters of Invitation for relevant District Officers of both the English and Scottish Constitution were approved by the Committee.
- Letters of Sponsorship for Overs in the Cricket Matches were approved by the Committee, printed and being distributed to Cooperate Bodies, Individuals, Lodges and Masons.
- List of items for the Benevolence Lunch and Cricket Match was prepared, discussed and approved by the Committee. Allocation of duties/responsibilities was also done in this regards.

#### Raffle

The Board anticipate to realize \$5,000,000 from this venture.

- The prizes include Honda Motor Cycle, Solar Power System, 40" Flat Screen Television, A Gold Chain and ten (10) Consolation prizes.
- 2,500 raffle books were printed and distributed at a cost of \$2,000 per book of 10 tickets.

The raffle will be drawn on the same day of the Guyanese Lunch and Cricket Match. The Committee will continue to meet regularly to ensure that all activities are properly monitored to fulfill its commitment to a successful programme for 2018/19.

I would like to take this opportunity to thank the members the Board for their cooperation and look forward to their continued support.

## INTERIM REPORT OF THE DISTRICT GRAND MENTOR

This report is a condensed version of the Mentor's Plan that was submitted and read at the Special Communication of the District Grand Lodge held at the Masonic Hall, Ferry Street, New Amsterdam, on Saturday, 21 July 2018. It summarizes the action points that will be done in the short term or in the next six months.

The first Mentor's Manual for our District was completed and reviewed by the District Grand Master, the Deputy District Grand Master and the President of the District Board of General Purposes. It has been submitted to the District Board of General Purposes for adoption and once approved will be circulated to all lodges through the lodge mentors. It must be noted that it is the first version of the manual and over time, and with inputs from lodge mentors and others, modifications will be done to enhance the overall effectiveness of the manual.

Under the guidance of the Deputy District Grand Master, other parts of the Mentors plan were also developed and in this regard several forms have been completed to standardize the accumulation of information across the District. Once adopted, these will also be circulated to the lodges.

The points below will form part of the other items to be actioned in the next few months and includes but will not be limited to:

- i. updating the Grand Mentor's Register;
- ii. meeting with lodge mentors to discuss proposals for the Mentorship Program;
- encouraging lodges to have events which include the participation of family members, new members and existing members who do not attend lodge meetings regularly;
- Investigating twinning members from different lodges to foster more interaction. This would be similar to a plan that was the brainchild of Bro. Clifford Van Domien, which is in its infancy stages but has led to more interactions between the brethren of Union and Alpha lodges, both at regular meetings, and socially. Resource pooling can aid in achieving common goals within a short time frame;
- v. commence a lecture series on a wide array of topics, including topics other than freemasonry;
- vi. introducing a Rookie of the Year Award. The general guidelines for this initiative are already available and the program will be submitted to the District Board of General Purposes for adoption. Thereafter, it will be launched through lodges and the new and young members' club.
